- ii. No disciplinary action is pending against him/her.

CLASSIFICATION OF THE DEGREE AWARD:

A student who qualifies for the award of the degree having passed the examination in all the courses in his/her first appearance securing a CGPA of not less than 8.00 shall be declared to have passed the examination in First Class with distinction.

A student who qualifies for the award of the degree having passed the CGPA of not less than 6.5 shall be declared to have passed the examination in First class.

All other students (not covered in clauses R.12.1 & R.12.2) who qualify for the award of the degree having passed the examination in all the courses shall be declared to have passed the examination in Second class.

REVALUATION:

A student can apply for revaluation of his/her semester examination answer paper in a theory course, within 10 Days from the declaration of results, on payment of a prescribed fee through proper application to the Controller of Examinations through Directorate of Distance Education. The Controller of Examination will arrange for the revaluation and the results will be intimated to student concerned through Directorate of Distance Education.

The Project Report is to be prepared according to the approved guidelines and duly signed by the supervisor(s) approved by the University and shall be submitted to the Directorate of Distance Education. If a student fails to submit the project report on or before the specified deadline, he / she is deemed to have failed in the project work and shall do the same in a subsequent semester.

CREDITS

After results are declared, Grade sheets will be issued to each student, containing the list of courses enrolled during semester and the grade scored the grade point average (GPA) for the semester and the Cumulative Grade point average (CGPA) of all courses enrolled from first semester onwards.

GPA is the ratio of the sum of the products of the number of credits of courses registered and the points corresponding to the grades scored in those courses, taken for all the courses, to the sum of the number of credits of all the courses in the semester.

GPA = (C*GP)/ C Where CGPA will be calculated in a similar manner, considering all the courses.

ELIGIBILITY FOR THE AWARD OF THE DEGREE

A Student shall be declared to be eligible for the award of the Degree provided if,

- The student has successfully completed the course requirements and has passed all the prescribed examinations in all the six semesters within the maximum duration
- ii. No disciplinary action is pending against him/her.

CLASSIFICATION OF THE DEGREE AWARD

A student who qualifies for the award of the degree having passed the examination in all the courses in his/her first appearance securing a CGPA of not less than 8.00 shall be declared to have passed the examination in First Class with distinction.

A student who qualifies for the award of the degree having passed the examination in all the courses within the minimum duration securing a CGPA of not less than 6.5 shall be declared to have passed the examination in First class.

All other students (not covered in clauses R.12.1 & R.12.2) who qualify for the award of the degree having passed the examination in all the courses shall be declared to have passed the examination in Second class.

The Vice-Chancellor observed that the syllabi of the programes offered through Distance Education should be the same as that offered under regular programme. He also said that the exams of the Semester based programmes should be conducted with the same question paper and at the same time as that of the regular programme. He further noted that the course material should be developed with unique identity of SRM University at high quality.

With the above observation it is RESOLVED that the curricula recommended for the above 18 programs to be offered through distance mode be APPROVED by adopting the same syllabus as adopted for the regular courses.

Other item 1:

Conducting a second Examination for the 1st Professional MBBS Examination:


